Barbara H. Partee是美国马萨诸塞大学著名语言学和哲学教授，国际上资深的蒙太格语法研究专家和形式语义学奠基人之一。19世纪60年代师从当代著名语言学家N. Chomsky获得博士学位，1986年担任美国语言学会主席，后当选为美国国家科学院和文理科学院院士，荷兰皇家文理科学院外籍院士。多年来一直是Linguistics and Philosophy等重要形式语义学刊物的编委。
