社会成长与国家治理——以中国社会治安综合治理为分析对象

摘要: 从总体性治理到综合治理是建国后中国国家治理方式演进的基本脉络, 也是转型中国国家——社会关系变革的主要内容。从一定意义上讲, 社会治安综合治理是透视转型中国社会成长与国家治理互动关系的最佳窗口。从中国政治发展的现实经验来看, 国家治理方式的变革是在社会转型的背景下展开的, 社会成长是国家治理方式演进的内在动力。同时, 国家治理方式的演变也为社会成长创造了更有效的政治空间。当代中国国家治理的核心战略就是如何在社会成长与国家治理之间构建良性的互动关系, 通过有效的国家治理促进社会的成长与成熟, 进而构建与成熟现代社会相适应的弥散型国家治理模式。

The promotion of a civil society and state governance ——An analysis of China's comprehensive governmentality of social order

Abstract: The process from totalitarian governmentality to comprehensive governmentality is the basic skeleton of the evolution of China's approaches to state governance and the main content of state-society relationship's change in transitional China after the foundation of the PRC. By and large, comprehensive governmentality of social order is the best window to observe the relationship between state governance and promotion of a civil society. In the aspect of real experience in the China's political development, the change of approaches to state governance was demonstrated under the background of social transformation. Hence, the promotion of a civil society is the inner dynamic to the evolution of China's approaches to state governance. At the same time, the latter creates more effective political space for the former. It is the core stratagem of modern China's governance through building up benign relationship between promotion of a civil society and state governance and accelerating the growth and maturation of civil society by effective state governance. Finally, China will build up dispersive model of state governance to adapt to mature and modern society.
