摘要:

Abstract:

The issue of elder abuse not only influence on the elders' physical and mental health seriously, but also increase the social burden of geriatrics disease and the corresponding social welfare agencies. The text reviews the general concept, type and characteristics, total incidence rate and all kinds of abuse, and risk factors of social psychology and psychopathology, thus the elder abuse can be identified and intervened.
