摘要:

对于心室收缩不同步的心力衰竭患者,心脏再同步化治疗可缓解症状、降低死亡率。经典的心脏再同步化治疗主要用于纽约心脏病协会(NYHA)心功能III-IV级患者。新近提出的心力衰竭4期分期提示,对心力衰竭患者应早期预防、早期治疗。最新研究提示,对NYHA心功能 I - II 级患者,心脏再同步化治疗可延迟心力衰竭的进展。
