Education and Training

I completed Family Medicine residency training at Thomas Jefferson University in Philadelphia (1985-88), followed by an Adolescent Medicine fellowship at Johns Hopkins School of Medicine (1988-90). I joined the Department of Family and Community Medicine in 1990. I was promoted to Professor in 2010 and appointed to Vice Chair for Research in 2012.

Biosketch

For over 25 years I have provided the full scope of family medicine care to Baltimore's vulnerable populations and have designed, conducted, and disseminated research and training projects. Program building and evaluation, community collaboration, and participatory engagement with vulnerable populations have been recurring themes of my research. My main research achievements have been in characterizing behavioral and psychosocial risk factors for socio-economically disadvantaged groups, in particular pregnant and parenting adolescents. Our work has expanded understanding of the relationship between teens' risks and poorer outcomes, how achieving defining attributes of primary care (e.g. access; comprehensiveness) can reduce morbidity, and the role of patient-centered counseling styles (motivational interviewing) in improving outcomes. I am co-PI of Maryland's Evaluation of Maternal Infant Early Childhood Home Visiting (MIECHV) Project in which we focus on strategies to strengthen services integration between primary care and community sectors. The purpose of Maryland MIECHV is to strengthen the role of home visiting in improving health and developmental outcomes and in eliminating disparities in Maryland's priority areas for expectant families and families with young children. My clinical quality improvement work focuses on promoting primary care systems redesign to advance patient-centered, evidence-based, population-focused care across the lifecycle.
