KARACHI

POST- BUDGET SEMINAR ORGANISED BY KARACHI BRANCH COUNCIL

Karachi, Monday, June 19, 2006: Sardar Nadir Akmal Khan Leghari, Minister for Irrigation and Power, Government of Sindh and the Chief Guest at Post Budget Seminar organized by Karachi Branch Council under the aegis of the Institute of Cost and Management Accountants of Pakistan (ICMAP) praised the government for presenting 'poor friendly budget'.

The Chief Guest said the fiscal year 2005-2006 has been the year of economic expansion and accelerated growth, which was a consequence of the continued macro economic stability and consistent policy framework with a planned shift in the focus of the policy makers to achieve higher growth.

The Chief Guest summarized the key features of the Budget 2006-2007 have been received with mixed reactions ranging from political bias including cynicism to a more proactive and comprehensive analysis. The seeds of macro economic stability have started blossoming and require a lot more care and pragmatic approach to ensure that we are in a position to reap the desired results in the form of achieving Millennium Development goals (MDGs) and harmonizing with a Medium Term Development Framework (MTDF). "Now defence expenditure is Rupees 250 billion whereas development budget is Rupees 415 billion. This is the result of positive thinking, framing fiscal laws with economic rationale and adoption of international best practices. However, we should not be complacent. We have yet to bridge a wide gap," Chief Guest concluded.

Sher Afgan Malik, President of ICMAP said that the increase in minimum wage, review of salaries of government employees, rationalizing of tax incidence for salaried persons is positive steps to address the concerns. However, the high inflation particularly food inflation and SPI growth has seriously affected the low-income groups of the society who were expecting far more from the Government. The MTDF has an objective to reduce poverty by 2010 to 21 percent but in order to ensure that the demonstrative effect of the reform process is recognized at micro level, a lot more is required to be done even if it requires readjustment of fiscal deficit figures in a short to medium term.

Sher Afgan Malik, President of ICMAP informed that despite job creation through SME and micro finance activity and growth in economy, unemployment level has remained unchanged and it needs to be addressed through a martial plan.

Malik said we would like to reiterate that as a society we still need to work hard to organize ourselves as common nodes with a sense of tolerance, mutual respect, confidence in our judicial process and equity in allocation of resources with long term focus in narrowing the

gap between the top income level and lowest income level groups in terms of people, provinces and local constituencies.

Political differences are prerequisite for any good society and culture to put pressure on government in power to ensure more transparency, good governance and accountability. However, we still do need national solidarity and pride and confidence in our ability and potential. Our perception of future in terms

of external relations and economic growth and development must reconcile on certain minimum parameters, which cannot be compromised to ensure national integrity and sovereignty.

President ICMAP in his concluding remarks emphasized that the government needs more and more resources urgently to develop infrastructure to create jobs and alleviate poverty ad added that only an effective tax net could solve this problem.

Abrar Ahmed, Regional Commissioner of Income Tax Regional Commissioner termed the federal budget 2006-2007 a balanced one.

Regarding income tax on salaried class, he said new tax provisions were beneficial for the salaried people, however, there were some negative impacts on the people having earning ranging from Rupees 0.4 to 2 million per annum and assured there would be working on the issue and no one would be left to suffer.

Abrar Ahmed said the CBR was very receptive regarding relief to the people and claimed wherever there was any demand or requirement for relief it was given. He maintained there was a long demand of brining down tax rates, which had been entertained. He said the tax net was being extended, as this would reduce the burden from the taxpayers.

Regional Commissioner of Income Tax in his speech in ICMAP Post Budget Seminar on Monday, while withdrawing 5 percent customs duty on the import of computer hardware, announced levy of 15 percent general sales tax (GST) on the import and local supply of computer hardware. The withholding tax has also been slashed from 6 to 1 percent on the computer parts.

In a move to tax the rich people, 15 percent excise duty on international air travel has been proposed bringing it at par with the domestic air travel where 15 percent excise duty is applicable. The levy would rationalize the excise tariff, besides bringing a positive effect on the public exchequer. The levy would not be applicable on the Hajj fare/ticketing.

Mushtaq Ahmed Vohra, Chairman APTMA, Sindh-Balochistan Zone, informed prominence of Sales Tax and Federal Excise Duties proposed in the Federal Budget 2006-2007 are as follows: -

- Withdrawing excise duty on travel by train.
- Zero-rating of sales tax on dairy products and stationery items.
- Providing sales tax zero-rating on import and supply of trucks and dumpers.
- Amending sales tax and excise laws to improve the working of ADRC.
- Withdrawing exemption of sales tax on computer hardware.
- Levying 15% excise duty on international air travel.
- Levying 5% excise duty on commission and brokerage of foreign exchange dealers, exchange companies and moneychangers.
- Excise duty 5% shall be levied on the gross amount paid by the franchisee to franchiser for having the right to sell products under his brand name or trademark.
- Increasing retail price of cigarettes. Cigarettes are chargeable to excise duty on the basis of retail price.
- Enhancing the rate of excise duty from 3 to 5 % on insurance service.

His focus was on Computer System, E-Intermediaries, Records, Value of Supply, Tax Credit, Returns, Special Audits, Offences and penalties, Time limit of Adjudication, Appeals, Alternative dispute resolution, Zero Rating, Rules of Sales Tax, Black listing and suspension of registration, refund, debit notes, credit notes, Payment of sales tax, sales tax on electric power companies and sales tax on vehicles.

Question answer session was one of the important segments of the seminar. The participant's questions were mostly in area of Sales Tax, Income Tax and poverty elimination efforts by the Govt. Development expenditures and share of provinces in total budget were questioned and answered.

Haji Ahmad, Regional Income Tax Commissioner, as chief guest showed his gratitude to ICMAP, Lahore for organizing a seminar on important topic of Budget 2006-07. He was of

He added that this practice would not make the industrialists happy nor would it reduce the poor people's problems He suggested that the government should establish a separate ministry of strategic planning.

Dr. Ikramul Haq also criticised the government for the budget. Huzema Bukhari termed the budget "disappointing and unrealistic", saying," If we want to see a progressive Pakistan, we have to set our priorities and directions".

Mirza Munawar said that incentives were offered to the common man in the budget and more steps were being taken to facilitate them. He said that tax on real estate businesses would ruin small investors and that the government should revise these measures.

At the end of the seminar Mr. Naeem Haider Secretary FBC delivered voted of thanks and appreciated the efforts of FCCI and ARY One World TV.
